Trusting What You're Told

Author of Biographia Literaria (1817) and The Friend (1809-10, 1812 and 1818), Samuel Taylor Coleridge was the central figure in the British transmission of German idealism in the 19th century. The advent of Immanuel Kant in Coleridge's thought is traditionally seen as the start of the poet's turn towards an internalized Romanticism. Demonstrating that Coleridge's discovery of Kant came at an earlier point than has been previously recognized, this book examines the historical roots of Coleridge's life-long preoccupation with Kant over a period of 20 years from the first extant Kant entry until the publication of his autobiography. Drawing on previously unpublished contemporary reviews of Kant and seeking socio-political meaning outside the literary canon in the English radical circles of the 1790s, Monika Class here establishes conceptual affinities between Coleridge's writings and that of Kant's earliest English mediators and in doing so revises Coleridge's allegedly non-political and solitary response to Kant.

Natural Capitalism

Here Jerome Murphy-O'Connor presents a completely new, and much more vivid and dramatic account of the life of Paul than has ever previously been attempted. From his childhood in Tarsus and his years as a student in Jerusalem to the successes and failures of his ministry, this biography has no peer in terms of its detailed reconstructions of Paul's movements and motives. Traditionally, the Acts of the Apostles has provided the framework for the lives of Paul. In recent years, however, the historical value of the Acts has been called into question. Despite the accuracy of many details, they have been linked in ways which reflect the interests of Luke rather than objective reality. Critical assessment is called for if they are to be incorporated into a life of Paul. The prime source for a reconstruction of the Apostle's life must be his own writings. Recent advances in the study of the letters have brought to light new depths which enables them to be used for biographical purposes. The originality of this book lies in the combination of these two approaches, which are reinforced by close attention to the social and cultural aspects of Paul's ministry as revealed by archaeology and contemporary texts—and it transforms a fountain of theological ideas into a human being.

Paul: A Critical Life

Beyond Pure Reason

St Paul's was the principal church of London from its foundation in A. D. 604. This volume is an edition of all the surviving documentary material from St Paul's from the seventh century to 1066, with expert analysis and commentary on the history of the bishops and the cathedral community within the city and diocese, considered against the background of London's history during this period. The medieval archives of St Paul's suffered at times from neglect, and as a result the majority of the Anglo-Saxon charters of the bishop and chapter are preserved only as fragments in the notebooks of two seventeenth-century scholars who studied a crucial manuscript before it disappeared at the time of the Commonwealth. These excerpts are here edited with full diplomatic and historical commentary, which makes it possible to resurrect to some extent the full documents. The edition of the charters is prefaced by an extended introduction which provides an important new synthesis of the history of London and St Paul's in the Anglo-Saxon period, complete with an extensive bibliography.

Underpinning this urban landscape is an evolutionary resilience that has maintained the basic spatial framework of the metropolis and sustained its imitable character. The city's institutional framework has been severely ruptured and reinvented time and time again after fires, bombs, floods or wholesale redevelopment. Political unrest and racial conflict have resulted in riots, while successive rounds of investment and disinvestment have replaced elements of the built environment many times over. This book offers an insightful perspective into the distinctiveness of London as expressed through its socially significant buildings and districts.

L Is for London

The Swiss linguist Ferdinand de Saussure (1857–1913) revolutionized the study of language, signs, and discourse in the twentieth century. He successfully reconstructed the proto-Indo-European vowel system, advanced a conception of language as a system of arbitrary signs made meaningful through kinetic interrelationships, and developed a theory of the anagram so profound it gave rise to poststructural literary criticism. The roots of these disparate, even contradictory achievements lie in the thought of Early German Romanticism, which Saussure consulted for its insight into the nature of meaning and discourse. Conducting the first comprehensive analysis of Saussure's intellectual heritage, Boris Gasparov links Sassurean notions of cognition, language, and history to early Romantic theories of cognition and the transmission of cultural memory. In particular, several fundamental categories of Saussure's philosophy of language, such as the differential nature of language, the mutability and immutability of semiotic values, and the duality of the signifier and the signified, are rooted in early Romantic theories of "progressive" cognition and child cognitive development. Consulting a wealth of sources only recently made available, Gasparov casts the seeming contradictions and paradoxes of Saussure's work as a genuine tension between the desire to bring linguistics and semiotics in line with modernist epistemology on the one hand, and Jena Romantics' awareness of language's dynamism and its transcendence of the boundaries of categorical reasoning on the other. Advancing a radical new understanding of Saussure, Gasparov reveals aspects of the intellectual's work previously overlooked by both his followers and his postmodern critics.

Teaching English 3-11

London's suburbs are home to many thousands of people who travel into the centre every day to work, but they also house many thousands who rarely find a reason to do so. They contain all the essential infrastructure for the city, too, including airports, offices, shopping centre, factories and warehouses. Outer London is therefore both metropolitan and suburban at the same time - it is Metroburbia. In this book Paul Knox examines the architectural history and development of London's suburbs, and celebrates their surprising variety and organized structure, refuting the common claim that they are monotonous or amorphous. The first chapter, The Foundations of Metroburbia, explains the foundation and development of Metroburbia and looks at how topography and geology influenced the siting of the villages that would become part of Greater London. The River Thames, of course, is one of London's most important and well-known structural elements, and in this chapter Knox examines how its meanders and bends have produced distinct patterns of settlement and

development. He also describes in detail the seven distinctive sectors of London, which are (running clockwise from the west) the Thames Valley, Northwest London, North London, the Lea Valley, Northeast London, the Thames Estuary and South London. Finally, he looks at how early settlements, country estates and royal palaces shaped Metroburbia, and how the increase in roads and industry consolidated the development of what would become suburbia. Chapter 2, Pattern-book London, looks at Victorian and Edwardian suburbs - the first developments to be given that name. The building booms and their effect on employment in the city, and the difference in style and purpose between the various suburbs, are discussed, and Knox also examines the effects of immigration and industrialization on the city's housing requirements. He also describes the genesis of the parks, cemeteries and garden villages that now provide such valuable green space for Londoners, and the creation of the impressive industrial, civic and institutional buildings that are still striking parts of the city's infrastructure. Chapter 3, Inter-war Suburbia: Metro-Land and the Universal Plan, describes the acceleration of building projects between the wars and the beginning of the transition from Edwardian society to the modern welfare state. The term "Metro-Land', introduced by the Metropolitan Railway Company in the early twentieth century, gives the chapter its title, and describes the expansion of residential London along the route of the Underground lines into Buckinghamshire. The effect of widespread car ownership is discussed, and the various housing styles - Stockbroker Tudor, Suburban Moderne, the mansion block, and so on - are described. The fourth chapter, Secular Reformation and Modernism, covers the thirty years from the end of the Second World War, during which time the welfare state brought about radical changes to life in London and the architecture of the city. Chapter 5, Counter-Reformation, describes the changes wrought on the country by the new neo-liberal agenda, as the welfare state was overtaken by a market-driven economy that fostered freefor-all development. By this time Metroburbia had spread outwards to incorporate Chelmsford, Southend-on-Sea, Maidstone, Guildford, Reading and Luton. This was an era of radical new infrastructure projects - from the rise of the suburban shopping centre to the construction of the new Thames Barrier - and huge increases in house prices. The regeneration of the Isle of Dogs into the Docklands commercial area is one of the most high-profile developments of the era, but infill house-building and small-scale environmental developments were also produced, and social housing regenerated. Finally, the last chapter, Megapolitan Futures, explores the various theories about the capital's future and conjectures about the shape of the city in the twenty-first century.

Alongside audio poetry, the book discusses the spoken word including documentaries and public announcements, the radio feature, soundscapes, sonic art with contributions from key figures such as Colin Black (Australia) and Marcus Leadley (UK) and the poetry of the vernacular in speech and sound. It considers new platforms for listening including podcasts and developments in mobile technologies, examining the work of current practitioners including Francesca Panetta, who is responsible for The Guardian's podcasts as well as the award-winning Hackney Podcast, and Tim Wright.
